

ExpoWELDING 2010 Competition Terms and Conditions

§ 1

The Competition is organized by Kolporter EXPO Sp. z o.o.

§ 2

The aim of the Competition is to award and honour the most interesting and original products/services and solutions for the welding industry presented at the International Welding Fair ExpoWELDING 2010.

§ 3

To enter the Competition the company must be an Exhibitor at ExpoWELDING 2010 and:

a) send in (or otherwise submit) a completed Entry Form to the Organizer's address:

Kolporter Expo Sp. z o.o., ul. Braci Mieroszewskich 124, 41-219 Sosnowiec

by 15th October 2010, 4 p.m.

b) submit a confirmation of entry fee payment or make the payment at the Fair Office.

c) in case a product/service entered in the Competition by an Exhibitor is not his property, a written consent from the rightful owner is required.

§ 4

Along with the Entry Form, participants should submit (or make available to the Panel of Judges at the company's stand):

- technical and informational materials about the product/service – containing the name of the product/service
- certificates, patent applications, etc.
- other relevant materials helpful in assessing the value of the product/service.

§ 5

Companies are entitled to enter more than one product/service in the Competition. For each item, however, a separate Entry Form must be completed and a separate entry fee must be paid. Products entered in the Competition and presented at the Fair should be marked „produkt/usługa zgłoszona do konkursu” (product/service entered in the Competition) and made available to the Panel of Judges.

§ 6

By entering a product/service in the Competition, the Exhibitor agrees to all the information (unless confidential) and photographs of the product being used for free in publications released by Kolporter Expo Sp. z o.o. or the media co-operating with it.

§ 7

A Panel of Judges will be appointed by the Organizer. The Panel will be made up of four renowned Polish experts in the field of welding. The Panel's meeting will be strictly confidential. Its decision will be final and independent of the Organizer.

§ 8

Criteria for the evaluation of the products/services:

- 1) utility and functionality,
- 2) originality,
- 3) wide scope of application.

§ 9

The winners of the Competition will receive Expo Silesia Medals. The honoured companies will receive diplomas. The Panel of Judges reserves a right not to award Medals or diplomas in a given category. Moreover, Kolporter Expo Sp. z o.o. is entitled to award a Medal and a diploma for the best arranged stand in terms of promotion. In this category no Entry Form or entry fee are required and all exhibition stands at the Fair will be taken into consideration.

§ 10

The Panel of Judges will meet on the first day of the Fair, i.e. on 19th October 2010. The decision of the Panel will also be announced and awards will be presented on the first day of the Fair at the Exhibitors' gala.

§ 11

The awarded companies will be able to put the medal image or the diploma image on the winning/honoured products and use them in the company's promotional activities. Winners' list will be published on the Fair official website.

§ 12

Entry fee per one product/service entered in the Competition is 300 PLN + 22% VAT.
